The European Sustainability Reporting Standards (ESRS) have been approved and will apply from January 1, 2024, as mandated by the Corporate Sustainability Reporting Directive (CSRD). This directive aims to enhance and standardize sustainability reporting across the European Union.

The ESRS provide a comprehensive framework for companies to disclose information on environmental, social, and governance (ESG) factors, ensuring transparency and comparability in sustainability reporting.

Companies subject to the CSRD should prepare to align their reporting practices with these standards to meet the upcoming requirements.
